8 <sup>th</sup> May 1997	DI Michael Irwin	Received intelligence/ evidence from a potential witness as to the identity of Robert Hamill's attackers, also that one of the landrover crew, namely Reserve Constable Robert Atkinson, had "tipped off" one of the named suspects advising him to destroy clothing he was wearing to prevent forensic linkage to the crime.
8 <sup>th</sup> May 1997	DCS McBurney	DCS McBurney was appointed as the Senior Investigating Officer (SIO). DCI <sup>P39</sup> was appointed as his deputy and DI Irwin was the identified Office Manager.
	DCI <mark>P39</mark> DI Inwin	Mr. was the appointed Supervising Member, representing the Independent Commission for Police Complaints (ICPC).

12 <sup>th</sup> January 1998	ICPC	Having supervised the misconduct investigation into the actions of the landrover crew, the ICPC issued a Certificate of Satisfaction, in that it was their view that all relevant lines of enquiry had been completed.
		However adverse comment was made as to the actions of two of the landrover crew, namely the driver and supervisor Reserve Constable Neill along with Reserve Constable P40

29 <sup>th</sup> September 1999	DPP	Following the above proceedings the DPP considered that there was no further information/ evidence forthcoming and directed no prosecution of any member of the landrover crew.  This included the alleged criminal conduct of Reserve Constable Atkinson.
30 <sup>th</sup> March 2000	ICPC Chief Inspector	Upon receipt of the DPP's direction that there should be no prosecution of any of the landrover crew, the RUC Complaints & Discipline Department commenced a disciplinary investigation, the appointed SIO being Chief Inspector Bradley.
	Bradley	In short the suspect officers all agreed that their previous criminal interviews, could be adopted as a part of the disciplinary process.
		Whilst the outcome resulted in the ICPC issuing a Certificate of Satisfaction, as to the completeness of the C & D investigation, it was done so on the understanding that this was a two stage process and that the ICPC would then consider the endorsement, or otherwise, by the Assistant Chief Constable, as to any formal disciplinary recommendations made by the IO, Chief Inspector Bradley.

The primary reason being that without the live evidence from witnesses who had since retracted their evidence and were in fear of reprisal, there would be little value to the process.
14 <sup>th</sup> & 20 <sup>th</sup> June 2000	DCS McBurney DI Irwin	Following the marriage break of the alibi witnesses who had previously supported Reserve Constable Atkinson's account, that he had not been responsible for "tipping off" one of Robert Hamili's attackers, DCS McBurney decided to re-interview both parties.  During this process one of those concerned admitted that the alibi evidence they had provided was false.
21 <sup>st</sup> June 2000	Chief Constable Sir Ronnie Flanagan	The Chief Constable met with the ICPC and notified them of the above development, in-turn he invited the ICPC to supervise the re-investigation into the alleged criminal conduct of Reserve Constable Atkinson.
