SPOKE TO THOMAS MALLON [REDACTED] ON 290497 AT PORTADOWN RUC STATION. MR MALLON STATED THAT HE LEFT ST PATRICKS HALL A SHORT TIME AFTER 0100 HRS ON SUNDAY 270497. HE WALKED DOWN THOMAS ST & CROSSED MARKET ST TOWARDS WOODHOUSE ST. AS HE CROSSED MARKET ST HE SAW GROUPS OF WHICH HE THOUGHT TOTALLED 30 TO 50 YOUTHS COMING UP HIGH ST TOWARDS MARKET ST. HE WENT OVER TO THE RUC LANDROVER WHICH HE SAW MOVING FROM THE MOUTH OF WOODHOUSE ST & SPOKE TO THE POLICEWOMAN IN THE FRONT PASSENGER SEAT. HE TOLD HER THAT THERE WAS OTHERS COMING DOWN THOMAS ST FROM ST PATRICKS HALL & THAT THEY SHOULD STAY WHERE THEY WERE PARKED IN CASE ANYTHING HAPPENS WITH THE CROWD COMING UP THE STREET. HE STATED THAT THE POLICE AGREED WITH HIM & PARKED IN FRONT OF THE HALIFAX BUILDING SOCIETY HE WENT ON DOWN WOODHOUSE ST & HOME. HE DID NOT SEE ANY ASSAULT OR DID HE SEE ANYONE ELSE COME DOWN THOMAS ST FROM ST PATRICKS HALL WHILE HE SPOKE TO THE POLICE. HE DID NOT HEAR ABOUT THE ASSAULT ON ROBERT HAMILL UNTIL AFTER HE GOT UP ON THE SUNDAY MORNING. DECLINED TO MAKE A STATEMENT
