SPOKE TO BEVERLY IRWIN [REDACTED] WHO WAS ON THE PREMISES WITH OTHER STAFF, STEPHEN THORNBURY, DEREK LITTLE AND JULIE SHERWOOD. LAST CUSTOMER LEFT 1.30AM. WITNESS WENT TO SHUT ROLLER SHUTTER DOOR OUTSIDE THE EMERGENCY FIRE DOORS AT 1.45AM WHEN SHE HEARD PEOPLE WALKING DOWN THOMAS STREET SHOUTING FUCKING ORANGE BASTARDS, WAS SHOUTED 3/4 TIMES. WITNESS STEPPED BACK FROM DOORS THINKING THESE PEOPLE WERE COMING IN. SHE TOLD JULIE SHERWOOD TO TELL STEPHEN THORNBURY WHO CAME UP TO BEVERLY. BOTH LOCKED OUT BRIEFLY SAW FIGHT IN PROGRESS. WENT BACK INTO BAR CASHED TILLS UP AND PARTIALLY SET ALARM. WENT INTO LOUNGE AND WENT OUT THROUGH LOUNGE DOORS OTHER STAFF LOOKED THROUGH TOILET WINDOW. WITNESS SAW MAN IN DARK CLOTHES LYING ON ROAD IN A RECOVERY POSITION GIRL WITH HIM CRYING. SAW OLDER MAN 40'S RECEDING HAIR CUT SHORT ROUND NECKED JUMPER AND POSSIBLY BROWN JACKET TRYING TO GET ANOTHER MAN IN HIS 20'S TO LEAVE THE AREA. THIS PERSON WAS ABUSIVE TOWARDS PROTESTANT CROWD. SAW AMBULANCE ARRIVE. STAYED ON THE STREET 5 MINS WENT BACK INTO BAR LEFT AT 2.45AM. WILL NOT MAKE WITNESS STATEMENT.
