THE 26TH APRIL 1997, HE WENT TO THE COACH IN BANBRIDGE. HE
TRAVELLED BACK FROM THE COACH BY BUS, ARRIVING IN PORTADOWN
ABOUT 1.30AM. HE WAS ACCOMPANIED BY HIS BROTHER MARK, AND JASON
WOODS. AS FAR AS HE CAN RECALL, HE WENT TO HERRONS COUNTRY
FRIED CHICKEN & GOT SOMETHING TO EAT. (BLACK STATED THAT HE HAD
TAKEN A FEW DRINKS IN BANBRIDGE BUT THAT HE WAS NOT DRUNK.) HE
THEN WALKED UP THE MAIN STREET IN PORTADOWN WITH HIS BROTHER
HE WAS GOING TO STAY THE NIGHT IN THE BROTHERS FLAT IN JERVIS
STREET SO THEY WALKED UP WEST STREET. WHEN AT THE JOB CENTRE IN
WEST STRET, HE HEARD A COMMOTION/SHOUTING DOWN IN THE CENTRE
OF TOWN. HE WALKED BACK DOWN TO THE BIG CHURCH AND HE WAS TOLD
BY OTHERS THAT THERE WAS FIGHTING GOING ON, DOWN THE TOWN. HE
DID NOT GO ANY FURTHER THAN THE CHURCH. HE DID NOT SEE OR
RECOGNISE ANYONE FIGHTING THAT NIGHT IN THE TOWN CENTRE. HE
COULD NOT RECALL SEEING ANY POLICE OR POLICE VEHICLES IN THE
TOWN CENTRE THAT NIGHT, BUT STATED THAT NORMALLY THERE IS A
POLICE LANDROVER IN THE TOWN CENTRE: JOSEPH BLACK DENIED BEING
INVOLVED IN ANY TROUBLE IN PORTADOWN TOWN CENTRE THAT NIGHT OR
BEING INVOLVED IN ANY ATTACK ON ROBERT HAMILL. HE WALKED TO
MARKS FLAT WITH APPROX. 6 PEOPLE, BUT NONE OF THEM CAME IN.
THEY ALL WALKED ON TO THEIR OWN HOUSES. HE COULD NOT RECALL WHO
THESE 6 PERSONS WERE.
