PRO FORMA ATTACHED, WHEN FIRST SPOKEN TO P46 DID NOT MENTION THE PARTY.  
HE DESCRIBED COMING HOME FROM THE COACH, GETTING OFF THE BUS WITH TRACEY  
CLARKE AND KELLY LAVERY - GOING TO BOSS HOGGS FOR CHIPS AND WALKING ALONG  
MARKET STREET IN THE DIRECTION OF MCCONVILLES. STATED THAT WHEN HE WAS IN  
THE AREA OF THE CHURCH HE HEARD A 'BOTTLE' BREAKING. HE STATES AT THAT TIME  
HE LOOKED ROUND, SAW A COMMOTION AND WALKED ON WITH THE TWO GIRLS BEFORE  
BEFORE GOING HOME. IT WAS PUT TO HIM THAT HE HAD NOT GONE  
STRAIGHT HOME AND HE THEN ACCEPTED THAT AT 0215 - 0230 HRS HE HAD GONE TO A  
PARTY AT TRACY NEWELL (MCALPINES?) HOUSE. HE OUTLINED THAT TRACEY CLARKE,  
TRACY NEWELL, DEAN FORBES, ANDREW OSBORNE NICKNAME OSSIE WHO WAS WITH A GIRL  
CALLED JUDITH FROM EDGARSTOWN, PAULINE NEWELL WERE AT THE PARTY. HE DENIES  
THAT THERE WERE OTHER PRESENT WHOM HE COULD NOT NAME BECAUSE HE WAS DRUNK.  
HE ALSO STATED THAT AT SOME STAGE DURING THE PARTY THE FIGHT WAS DISCUSSED  
BY WHOM HE WOULD NOT SAY. IT WAS DISCUSSED THAT 'ONE OF THEM BOYS' HIT WEE  
DAVY WOODS FROM [REDACTED] AND IT WAS THEN THE  
FIGHT STARTED. DURING THE COURSE OF OUR TIME WITH P46 HE WAS VERY  
NERVOUS, HE WELLED UP WITH TEARS AND BLUSHED FREQUENTLY. AT THE END IT WAS  
PUT TO HIM THAT HE HAD NOT BEEN ABSOLUTELY TRUTHFUL WITH US. HE DID NOT  
ACTUALLY SAY THAT WAS THE CASE BUT REMAINED SILENT BEFORE APOLOGISING THAT  
HE COULD NOT BE OF ANY MORE HELP.
