DOES NOT WISH TO MAKE A STATEMENT BUT OUTLINES THAT AT THE TIME OF THE INCIDENT HE WAS ALONE IN HIS HOME WHICH IS A 2ND FLOOR FLAT WHICH IS ONLY SLIGHTLY UP THOMAS ST FROM THE INCIDENT. HE WAS WATCHING TV AT THE TIME OF THE INCIDENT WHEN HE HEARD A FRACAS OUTSIDE. STATES HE LOOKED OUT THROUGH HIS WINDOW WHICH HE HAD TO OPEN. STATES HE SAW A FIGHT AT THE END OF OF THOMAS ST INVOLVING ABOUT 40 PEOPLE. HE DESCRIBES THE FIGHT AS INVOLVING TWO CROWDS WHICH CAME TOGETHER FIGHTING THEN STEP BACK MOMENTARILY BEFORE STARTING TO FIGHT AGAIN. HE RECALLS SEEING A POLICE LANDROVER NEAR CLARKES SHOP BUT DOES NOT RECALL SEEING POLICE ON THE GROUND. AT THETIME [REDACTED] THOUGHT THIS FIGHT HAD SPILLED OUT OF A PUB. HE ONLY OBSERVED WHAT WAS GOING ON FOR A FEW SECONDS AND CLOSED THE WINDOW BECAUSE THE LIGHT WAS ON. HE DESCRIBES THE CROWD AS BEING MADE UP OF MALES AND FEMALES, MOSTLY MALE. HE CANNOT DESCRIBE OR NAME ANYONE IN THE CROWD.

HE DOES NOT WANT TO MAKE A STATEMENT BECAUSE HE IS INVOLVED SOCIALLY WITH BOTH SIDES OF THE COMMUNITY IN PORTADOWN AND DOES NOT WANT TO BRING HIMSELF UNDER NOTICE.
