IT WOULD APPEAR THAT R/CONST ATKINSON LEFT THE POLICE STATION FIRST(A COPY OF HIS NOTEBOOK WOULD INDICATE THAT HE TERMINATED DUTY AT 0800HRS 27.4.97 BUT SEE A483 AND A484). ATKINSON WAS CONTACTED AT 05.51 AND RECALLED TO DUTY IN CONSIDERING THE INVESTIGATION STRATEGY BEING ADAPTED TO INVESTIGATE

P40 ANDRE MCKEE'S ALLEGATION DATED 20.6.97, THE DECISION TO RE-INTERVIEW NEILL, AND CORNETT FOR THE PURPOSE OF ESTABLISHING (A)WHAT TIME THEY ARRIVED INTO PORTADOWN POLICE STATION ON BEING RECALLED TO DUTY(B)WHAT INFORMATION ATKINSON SUPPLIED VERBALLY TO THE INVESTIGATION IN THE EARLY STAGES IN ADDITION TO HIS STATEMENT(C)THE EXACT TIME THAT ATKINSON LEFT THE POLICE STATION TO RETURN HOME AGAIN ON SUNDAY MORNING(27.4.97), TO PENDING UNTIL AFTER THE RE-INTERVIEW OF ANDREA MCKEE. RAISE FURTHER ACTION TO D/SGT H TO REAPPLY FOR OUTGOING TELEPHONE BILLING INFORMATION FOR PORTADOWN POLICE STATION FOR 27.4.97 TO ESTABLISH EXACTLY WHEN CORNETT AND P40 WERE RANG AND DIRECTED TO RETURN TO DUTY.
