SALIENT POINTS EXTRACTED FROM THE INTERVIEW RECORD RELEVANT TO THIS ACTION:-

1. P5 JOINED THE HAMILL MURDER INVESTIGATION TEAM ON MONDAY 12.5.97

2. P5 STATES THAT ON TUESDAY 13.5.97 HE ATTENDED A CONFERENCE CHAIRED BY D/INSP IRWIN, AFTER THE CONFERENCE HE ATTENDED TO COMPLETEION OF ACTIONS IN THE POLICE STATION.

3. ON 13/5/97, HE ACCOMPANIED D/CONST MCCRUMMLISH AND A NUMBER OF UNIFORMED OFFICERS TO CARRY OUT HOUSE SEARCHES AT (THE HOME OF ALISTAIR HANVEY) AND (THE HOME OF THOMAS HANVEY-ALISTAIRS UNCLE) -STATES THAT D/CONST MCCRUMMLISH OBTAINED THE SEARCH WARRANTS TO AUTHORISE THE SEARCHES.

4. D/C P5 STATES THAT HE CANNOT RECALL SPECIFICALLY WHO BRIEFED HIM AS TO THE OBJECTIVE OF THE SEARCH BUT HE CAN RECALL THAT THE SEARCH WAS FOR ITEMS OF CLOTHING WHICH MAY CONNECT ALISTAIR HANVEY TO THE MURDER OF MR HAMILL.

5. P5 STATES THAT AT THE TIME HE WOULD HAVE BEEN AWARE OF SPECIFIC ITEMS OF CLOTHING WHICH WERE SOUGHT BUT CANNOT RECALL WHAT THESE ITEMS WERE

BECAUSE OF THE PASSAGE OF TIME.

6. P5 CANNOT RECALL NOW ABOUT BEING BRIEFED TO SEARCH FOR A SILVER OR GREY COLOURED JACKET OR A DARK JACKET WITH GREY SLEEVES.

7. P5 STATES THAT WITH THE PASSAGE OF TIME THAT HAS NOEW ELAPSED HE CANNOT RECALL THE SPECIFICS OF THE BRIEFING GIVEN TO HIM;HE CANNOT THEREFORE RECALL BEING BRIEFED TO SEARCH FOR EVIDENCE OF BURNT CLOTHING.

8. P5 STATES THAT HE TOOK NO ACTIVE PART IN THE HOUSE SEARCHES WHICH

WERE CARRIED OUT BY D/C MCCRUMMLISH AND THE SEARCH TEAM.

9. I ASKED P5 COULD HE RECALL CARRYING OUT ANY CURSORY SEARCH FOR

BURNED CLOTHING, P5 STATES THAT HE CANNOT RECALL IT NOW BUT THAT IS NOT TO SAY THAT HE DIDNT CARRY OUT A CURSORY VISUAL SEARCH ALONG WITH D/C MCCRUMMLISH FOR EVIDENCE OF BURNED CLOTHING.

10. P5 STATES THAT FROM HIS RECOLLECTION, HE DOES NOT RECALL ANYTHING BEING SEIZED DURING THE COURSE OF BOTH HOUSE SEARCHES WHICH WERE

CARRIED OUT THAT DAY.
