SALIENT POINTS EXTRACTED FROM INTERVIEW RECORD RELEVANT TO THIS ACTION:

(1) D/C MCCRUMMLISH STATES THAT HE WAS BRIEFED TO CARRY OUT A SEARCH OF [REDACTED], HOME OF ALISTAIR HANVEY.

(2) DC MCCRUMMLISH RECALLS THAT A DARK COLOURED JACKET WITH GREY SLEEVES HAD NOT BEEN FOUND BY POLICE-RECALLS THAT HE WAS BRIEFED TO SEARCH FOR CLOTHING THAT HANVEY MAY HAVE WORN ON THE NIGHT OF THE MURDER, TO LOCATE AND SEIZE A JACKET WHICH FITTED OR WAS SIMILAR TO THIS JACKET WITH GREY SLEEVES AND TO SEARCH FOR EVIDENCE OF BURNT MATERIAL (CLOTHING)

(3) DC MCCRUMMLISH DOES NOT RECALL WHO BRIEFED THE SEARCH TEAM THAT ACCOMPANIED HIM

(4) DC MCCRUMMLISH STATES THAT WHILE THE SEARCH TEAM WERE IN THE HOUSE, HE SPOKE BRIEFLY WITH KENNETH HANVEY AND SEARCHED THE AREA OF GROUND IMMEDIATELY ADJACENT TO THE HOUSE, STATES THAT HE DID NOT GO BEYOND THE GARDEN AREA AND HE DID NOT GO INTO ADJOINING FIELDS-STATES THAT HE DID NOT GO INTO ADJOINING LAND BECAUSE THERE WAS NO OBVIOUS SIGNS OF RECENT TRACKS IN THE GRASS AREA SURROUNDING THE HOUSE, CANNOT RECALL SEARCHING ANY OUT-BUILDINGS-STATES THAT EXAMINED THE IMMEDIATE GROUND AROUND THE HOME, THE

SEARCH TEAM SEARCHED INSIDE THE PROPERTY.

(5) DC MCCRUMMLISH STATES THAT HE WAS ACCOMPANIED BY P5 [REDACTED] ON ATTENDING [REDACTED]

(6) DC MCCRUMMLISH STATES THAT HE FOUND NO EVIDENCE OF BURNT MATERIAL/DEBRIS IN THE AREA THAT HE SEARCHED AND NOTHING WAS SEIZED FROM THE SEARCH WHICH WAS CONDUCTED INSIDE THE HOUSE.

(7) DC MCCRUMMLISH STATES THAT THEY THEN WENT ON TO SEARCH [REDACTED]

HOME OF THOMAS HANVEY.
