SALIENT POINTS EXTRACTED FROM THE INTERVIEW RECORD RELEVANT TO THIS ACTION:

1. DC MCINTOSH STATES THAT ON SUNDAY 11/5/97, HE ATTENDED A CONFERENCE CHAIRED BY P39 [REDACTED] IN THE MORNING-STATES THAT HE WAS DIRECTED TO INTERVIEW THOMAS MERVYN HANVEY OF [REDACTED] PORTADOWN AND TO SEARCH THE PROPERTY-HE WAS DETAILED ALONG WITH DC MCCRUMMLISH TO CARRY OUT THIS DUTY
  2. DC MCINTOSH STATES THAT HE WAS BRIEFED TO SEARCH FOR ANY CLOTHING WHICH ALISTAIR HANVEY MAY HAVE WORN ON THE NIGHT IN QUESTION, HE RECALLS A DARK JACKET WITH GREY SLEEVES BEING MENTIONED AND HE WAS ALSO BRIEFED TO LOOK FOR ANY EVIDENCE OF ANYTHING BEING BURNT RECENTLY.
  3. DC MCINTOSH STATES THAT ON ENTERING THE PROPERTY, HE INTERVIEWED THOMAS HANVEY AND RECORDED A WITNESS STATEMENT-STATES THAT WHILE HE SPOKE TO THOMAS HANVEY, DC MCCRUMMLISH CARRIED OUT A SEARCH OF THE PROPERTY(SEE ACTION 667)
