1. The Relationship with the Atkinson's

1. When and in what circumstances did the McKee's first meet the Atkinson's
2. How close was their relationship - Was it purely on a social footing or was there any family/business relationship attached to it (See analysis - more telephone contact is noted between Atkinson's HA and the TKD Club - Was their relationship focused on the husbands
3. Did they regularly socialise with each other - How was this generally planned - What social activities did they participate in together as couples
4. Did they stay overnight in each others houses - What was the regularity of this - What sleeping arrangements facilitated this

5. Did the Atkinson's regularly visit their address - Did the Atkinson's ever stay overnight
6. What form of transport did they generally use to travel to each others houses if they were socialising
7. Can Andrea McKee ever recall an occasion when Eleanor Atkinson would have visited socially when Robert Atkinson was working - If so, how would she travel home
8. What other close friends socialised within their circle (ie Atkinson/McKee) - What is the link with [REDACTED] - Did the Atkinsons know [REDACTED] (see analysis list)
9. Were the Hanvey's close friends or was Andrea McKee's knowledge of them purely through the TKD Club organised by her husband
10. Does Andrea McKee ever recall a social gathering whenever the Atkinson's, Hanvey's (include Alistair), Clarke's (include Tracy) and them present - If so, in what circumstances did this occur
11. Did Michael McKee and/or Robert Atkinson have mobile phones in April - October periods in 1997
12. Can she remember the numbers - Does she have any old diaries or records - Apart from the TKD Club phone, how did they contact each other prior to 24/4/97 when their HA telephone [REDACTED] was first connected

1. In considering the call made from their HA at 1 30 am Sunday 27/4/97 (See next point), how did the McKee's spend Saturday night (Note:(a) the only call to or from the McKee's all day Saturday was made from [REDACTED]'s to the TKD Club at 10 27 am (b) the last telephone contact with the Atkinson's was at 8 36 pm on Thurs 24/4/97) - Can Andrea McKee recall what they during Saturday and Saturday night - How did they generally spend Saturday night - Did they have visitors to their house on that evening - If she cannot recall, who was likely at that time to have visited them on a Saturday night - Did they go out for the evening - where was this to (Note:use of Credit Cards etc)
2. Call made from McKee HA to McKee's Taxis, West Street at 1 30 am 27/4/97 for 39 seconds (The duration of the call would suggest that they knew who they were talking to within the Taxi Firm - In assisting Andrea McKee to recall the night in question, it may be of assistance to note from the telephone analysis that the only call made to McKee Taxis during a night-time period between Jan and Jun 1997 is recorded at 12 58 am on Sunday 18 May 1997 for 47 seconds)

  - \* Was a taxi ordered - If so, for what reason - If not, why make the call

  - \* Was the taxi ordered to deliver somebody/something to their address or collect somebody/something from their address
  - \* Did the taxi return to Portadown
  - \* If so, did the taxi and its occupant(s)? run into the incident in Portadown (Note:the Police moved the crowd into and along West Street away from the town centre and towards the taxi office)
3. There was no telephone contact between McKee's and Atkinson's on Sat 26/4/97 - the last telephone contact between them is noted at 8 36 pm on Thursday 24/4/97 for 3.42 mins (TKD Club to Atkinson) - this is the day that they got their home phone connected - Does Andrea McKee know what this call was about
4. How did the McKee's spend that Sunday morning (shopping/petrol/cash for example)
5. Did they see or speak to anyone at their house or during their movements during Sunday morning
6. How did Michael get to the TKD Club - Did she go with him - what time did he open the club - who would have been there at opening time - Is there any old Club records that she may have of this
7. The second call made by the McKee's on Sunday 27/4/97 was made from the TKD Club to a mobile [REDACTED] at 12 13 pm for 39 seconds

(this is the only occasion when this number appears in the analysis)

- Does Andrea McKee know who had that number - Has it got any relevance to this investigation

8. The first telephone contact between Clarke and the McKee's is a phone call made from Clarke's to McKee's HA at 12 40 pm on Sunday morning 27/4/97 for 9.59 mins (Note that this is the first time that the Clarke's had rang McKee's HA following the telephone installation on 24/4/97 - the timing appears significant) - What was this call about - Is this the first time that Andrea McKee had heard about the incident
9. When and in what circumstances did the McKee's first hear the story about what Tracy Clarke had witnessed - Which of them first heard the story and who did they first hear it from
10. If not initially Tracy Clarke, when did they first speak to her - Did they approach her or did she approach them - what did she tell them initially
11. Telephone analysis shows regular contact between the McKee's and Clarke's - In considering the evidence that Tracy Clarke (ex-girlfriend of Alistair Hanvey at that time) was to later give the police and the role that the McKee's later played in supporting Atkinson's cover story for explaining the contact with Alistair Hanvey - What was their relationship with Tracy Clarke at that time
12. See Clarke's Statement 10/5/97 - Clarke states that she saw 'Robbie Atkinson' - Did Tracy Clarke tell the McKee's about seeing Atkinson when she 'first' related the story to them - Does Andrea McKee know how Tracy Clarke had come to know Robert Atkinson
13. The first telephone contact between Atkinson and the McKee's after the incident is a call made from the TKD Club to Atkinson's HA on

Sunday 27/4/97 at 2 05 pm for 1.59 mins - the second call to Atkinson's HA on that day is made from McKee's HA at 7 pm for 27.53 mins (Note: Atkinson is possibly on duty - note telephone call from Portadown Police Station to Atkinson HA after this call) - What is being discussed and between who - Is the story of what Tracy Clarke witnessed known to the McKee's (see earlier conversation at 12 40 pm) and made known to the Atkinson's at this point - Can Andrea McKee recall when they first spoke to Robert Atkinson generally about the incident (see further points below which is intended to establish when Atkinson became aware of Tracy Clarke's position)

14. Does Andrea McKee know of any reason why Atkinson was ringing Sandringham Nursing Home on the morning of Sunday 27/4/97 (The relevance of this is unclear at this point - This is the only time that it appears in his billings in a 15 month period - Further calls are noted being made from Portadown Police Station at:

(a) 2 36 pm Mon 28/4/97 - See Action 489 - De-briefing by D/Sgt Bradley

(b) 10 10 am Wed 6/5/97 - Notes arrests of Bridgett (0745), [REDACTED] (0930) and Forbes (0745)

3. The first days of the investigation 28/4/97 - 13/5/97

1. Was Andrea McKee in direct contact with the Atkinson's during the first days of the investigation - How was Robert Atkinson reacting to it - What was he saying in relation to the incident or the investigation into it (There is no contact by phone between

Atkinson's home and McKee's home until 31/5/97 - Regular contact between Atkinson's home and the TKD Club is noted in 1997 - Is Robert Atkinson more friendly with Michael McKee - see analysis lists)

2. Does Andrea McKee know [REDACTED] or [REDACTED] who Atkinson rang on 28/4/97 - Did Atkinson ever refer to them at any time - If so, in what context
3. It would appear from Tracy Clarke's statement that she did not see Alistair Hanvey until the following Tuesday (?) - D/C McAteer who interviewed Clarke on 9/10 May believes that Clarke was referring to Tuesday night 29/4/97 - Is this correct - what can Andrea McKee say about when Tracy Clarke first spoke to Alistair Hanvey and what was Clarke's reaction to what he had told her about Atkinson
4. When and in what circumstances did the McKee's first hear the details about what Atkinson was alleged to have done (the phone call on Sunday Morning 27/4/97) - Was this from Clarke, Atkinson himself or somebody else - what was Andrea McKee's initial reaction - what was Michael's initial reaction
5. What does Andrea McKee know about the phone call from the Atkinson's to Hanvey's at 4 24 pm on 2/5/97 - Eleanor Atkinson later claimed responsibility for making this call - Does Andrea McKee have any information which would contradict this - Was Michael aware of this call - Did he ever make any comments to her about it (Note the earlier call from their HA to Atkinson's at 4 18 pm - Did this call lead to making the further call to the Hanvey's - Does Andrea McKee know if Atkinson was aware of what Alistair Hanvey told Tracy Clarke if that did occur on 29/7/97 (and not Tues 6/5/97)
6. The first telephone calls made from McKee's home to Clarke's is on

Sun 4/5/97 at 1 34 pm and 5 55 pm - what did Andrea McKee know at this point (see analysis lists)

7. On 6/5/97 telephone calls were made between Atkinson and the TKD Club (6 25 pm) and again from the TKD Club to Atkinson (7 05 pm) - Does Andrea McKee know what was being discussed between them on that day - Note: Bridgett, [REDACTED] and Forbes were arrested and release earlier this date (b) Alistair Hanvey will be interviewed as a witness tomorrow morning 7/5/97 - What does Andrea McKee know about how Robert Atkinson reacted to these actions
8. On 7/5/97 Clarke's ring Hanvey's at 8 23 am for 3.13 mins - What does Andrea McKee know about why and whom this call was made - Alistair Hanvey is interviewed by DS Bradley at approx. 10 am D/S Bradley visited the Hanvey home on 6/5/97 after tea time - spoke to father
9. On 7/5/97 a call was made at 10 22 am from Atkinson to the NIE? - 11.49 mins - A call made from the TKD Club to Clarke's at 2 43 pm for 39.25 mins (Note earlier call made) - What is being discussed between the Atkinson's and McKee's at this point - what is known by each of the parties (Note interview with Hanvey) - Does Andrea McKee know what involvement or knowledge Eleanor Atkinson had at this point
10. On 8/5/97 calls are made to Going Places where Tracy Clarke worked 9 55 am, 14 38 pm and 17 14 pm - this is unusual - (Note further calls to Clarke's HA from TKD Club at 5 27 pm and 5 38 pm) - Are the sequence and timing significant - If so, why is the phone activity significant - Does Andrea McKee know if Alistair Hanvey or Robert Atkinson were playing any part through Michael McKee in attempting to persuade Tracy Clarke from giving information to the Police

Investigation (See next point re first contact with the Police)

11. Tracy Clarke was first spoken to by D/C McAteer on the evening of 8/5/97 (See Questionnaire timed at 8 pm) - In noting the telephone activity leading up to this time - What did the McKee's know in relation to:

- (a) What she had witnessed at the incident involving Alistair Hanvey and the allegation involving Atkinson
- (b) What Tracy Clarke's intentions were in relation to giving that information to the Police
- (c) Police coming to speak to her that evening (there is no telephone contact between Portadown Police Station and Clarke's prior to this

12. On 8/5/97 a call is made from TKD Club to Clarke's at 9 29 pm for 1.43 mins (Note the sequence of calls before the interview took place and which followed after this) - What is this call about - What was being discussed - Who was talking to who - When did Andrea McKee and Michael McKee first speak to Tracy Clarke after that first interview - what did she tell them

13. On 8/5/97, 2 calls are made from the TKD Club to Portadown Police Station at 9 41 pm and 9 46 pm - Does Andrea McKee know who made these calls and why and to who these calls were made (Note: this is the evening that Tracy Clarke is being initially spoken to by DC McAteer - see questionnaire)

14. On 8/5/97, a call is made from Portadown Police Station to Atkinson's at 10 pm (see sequence of calls in point above) - Does Andrea McKee know what this is about - What did Michael and her do on the evening of 8/5/97 - Did they speak to Tracy Clarke after the interview - Did they see or speak to the Atkinson's at any point

that evening - Did Atkinson know at that time that Tracy Clarke had been seen - If so, what was Atkinson's reaction

15. [REDACTED] (Legahory Court) home telephone features regularly but on 8/5/97 there appears to to be an increase in telephone traffic between the McKee's and [REDACTED]'s HA - Did any person at that address know or have any involvement in the events around Tracy Clarke at that time - Did they have any relationship with the Atkinson's (see further comment re [REDACTED] 12 42 am on 10/5/97)
16. On 9/5/97, the first call noted from the McKee's (HA) to Clarke's is made at 10 30 am (Last call at 9 29 pm) previous night - see above) - What is being discussed between McKee's and Clarke's - Is Michael doing all the contacting - why (see below)
17. Tracy Clarke gave no information the night before - but will make a statement later on 9/5/97 - How did this come about - At what point and in what circumstances did Tracy Clarke decide to talk to the police - How did this come about - Did andrea McKee have any involvement with Tracy Clarke at this stage - If so, what was her involvement - When did the McKee's and Atkinsons first become aware that she would provide information - Were there any attempts being made to dissuade her - Was Atkinson involved in this (see point below)
18. Telephone analysis on the evening of 9/10 May shows a sequence of telephone contacts between the McKee's and Clarke's - See sequence and duration of calls between Clarke and McKee during periods (a) 8 21 pm and 8 31 pm (b) 11 24 pm and 12 39 am - What were the McKee's being told - Did they know that she was making a statement - Did they have any contact with Robert Atkinson during the night - What was Michael's reaction to Tracy Clarke making a statement -

When did the McKee's first speak to Atkinson after this - Did they tell him what Tracy Clarke had done and what she was alleging against Atkinson

19. Immediately after they ring Clarke's at 12 39 am, [REDACTED] phone [REDACTED] at 12 42 am - Why did they do this - What was discussed - What involvement or knowledge did Walker (or somebody at that address) have on this matter - Is there a connection between Walker and Atkinson

20. Immediately following the above call, [REDACTED] rings [REDACTED] at 1 am - Does this number mean anything to Andrea McKee (Subscriber [REDACTED] [REDACTED] from Burnside, Craigavon)

21. What was the state of the relationship between Tracy Clarke and Alistair Hanvey at that time - How long had the relationship been off before that - Was Michael aware of the state of their relationship at that time - Note telephone analysis shows regular contact between Clarke and Hanvey from January 1997 to around 20/4/97 when contact between their homes appears to stop (but see analysis re 'Going Places' - TC's work)

22. There is regular contact with Square Frames, Dromore - Is this [REDACTED] (See newspaper photograph) - Is he ex-RUC - He was being contacted from TKD Club on 28/4/97, 9/5/97, 12/5/97 and 16/5/97 (also contacted by Clarke's during 1997 period) - Did he know what was going on - Did he know Atkinson or know about the allegation - Did he have any involvement in or knowledge of what Atkinson is alleged to have done and the later conspiracy between Atkinson and Michael McKee to provide a cover story for the 'Hanvey' phone call

23. Did the McKee's have any contact with Atkinson on 10/5/97 (the day

Alistair Hanvey's arrest) - If so, what did they discuss (No phone contact noted - telephone contacts are noted between Portadown Police Station and Atkinson HA at 1 52 pm (17.19 mins) and 4 27 pm (20.26 mins)

24. On 12/5/97 (day of Hanvey's first Court appearance), McKee's HA rings Hanvey HA at 9 24 am for 10.02 mins - Who made this call and why (This is the only call linking the McKee to the Hanvey HA during 1997) - What were the Hanvey's told (See also call from Hanvey's to Going Places 9 13 am on 10/5/97?)
25. What was Atkinson's reaction when Hanvey was charged - Was he communication with the Hanvey's - How did he do this - Does Andrea McKee know if Atkinson ever contacted Kenneth Hanvey at NIE or Alistair Hanvey at his work in Unidaire
26. On 13/5/97 (day after Hanvey's remand), TKD Club contacts Clarke's at 10 24 am (18.58 mins) which is followed by a phone call from the TKD Club to Portadown Police Station at 11 07 am - What does Andrea McKee know about why or to who these calls were made in Portadown Police Station - If Michael McKee made them - why?
27. On 13/5/97 a number of calls are made from TKD Club to Hanvey's HA including a call at 6 58 pm for 11.55 mins - A later call is made from Clarke's to Hanvey's HA at 8 16 followed by a sequence of calls between the TKD Club and Clarke's - Where was Andrea McKee at this time - what does she know about why these calls were being made (see section dealing with retraction below) - Is Atkinson involved in this telephone activity in any way (Note the contact from Clarke's to Portadown Police Station during this sequence - 7 17 pm)
28. Did Atkinson ever discuss how the investigation was going inside Portadown Police Station with the McKee's during this period - Tracy

Clarke alleged that Atkinson was keeping Hanvey up to date on the progress of the investigation - Does Andrea McKee have information which would support this

29. Was Andrea McKee ever present in the same company as Atkinson and the Hanvey's when the investigation was discussed - Did she know if Atkinson was talking to the Hanvey's during this period - How did he do this - calls are noted from TKD Club to the Hanvey HA on 12 and 13 May - Why were these calls made - Was Atkinson present when calls were made - In what circumstances did he ever use the TKD Club

4. Atkinson's actions at the Incident

## 5. Telephone Calls to the HMP Maze and the Prison Visits

1. Calls were made from the TKD Club to the Prison on 14/5/97, 10/6/97 and 16/6/97 (Note that previous calls were made on 3/4/2/97 - why?)
  - Who made these calls and why were they made - Was Atkinson ever present when the calls were made - did he know that they were being made - What was his involvement in them being made
2. On 10/6/97 Alistair Hanvey receives visit from Mrs Hanvey, Miss Liggett, Miss Newell and Mrs McKee - Is this Andrea McKee - who are the other persons - how did they travel to the prison - How did Andrea McKee get into this position - What was her purpose for visiting Hanvey - Was Atkinson discussed within that group or during the visitation - See phone analysis for sequence of calls between McKee HA, TKD Club and Atkinson HA - What was being spoken between them about the visit later in the day
3. On 9/8/97 Hanvey received a visit from Mr McKee, Mrs McKee, [REDACTED], and [REDACTED] - Was this Michael and Andrea McKee - Identify the other persons - Address issues as above - Was Atkinson on holiday at this time (Atkinson's phone is quiet early August period)
4. On 26/8/97 Hanvey received a visit from Mrs Hanvey, Mrs McKee and Mr Cornett - Is this Andrea McKee - identify the other persons -

Address the issues as above - Is this Cornett from Orchard Drive that had regular telephone contact with Atkinson's HA - Atkinson on Sick Leave at this time - What is Tracy Clarke's position at this time regarding giving evidence (Note sequence of calls over this period regarding A Black - see below)

5. Did Atkinson ever visit or travel with them to the Prison - Did the McKee's visit at any other times - Did Tracy Clarke ever visit or were messages delivered between Hanvey and Clarke (Note that visits were made on 5/7/97, 28/7/97 and 5/8/97 for which there are no details)

6. The Interviews of Atkinson 9/9/97 and 9/10/97

1. Was the issue of the Hanvey phone call discussed between Atkinson and the McKee's prior to the first interview on 9/9/97 - When and where did this take place - Did Atkinson discuss with them how he would respond to questioning on this point - Did Atkinson consider a number of ways in which to cover this call - what were they - What was Eleanor Atkinson's involvement
2. What did Atkinson tell them after the first interview

7. What was discussed before and after the second interview of Atkinson on 9/10/97 (Michael McKee and Eleanor Atkinson made statements on the same day)
8. When did Andrea McKee realise that she would have to make a statement - Who asked her - Did she talk direct to Atkinson about it (Note the number and duration of calls towards the end of September 1997) - Did she ever talk to Eleanor Atkinson about it - Did she talk to anyone other than Michael McKee or the Atkinson's about her position or difficulty in making that statement
9. Andrea McKee made her statement on 29/10/97 - In making the statement, she had to be told what to say and why she was saying it - What was Michael McKee and Robert Atkinson's involvement in this

11. Why does Andrea McKee 'believe' that the Solicitor's bill was paid by Atkinson (Andrea McKee's statement 20.6.00)
