Attached are copies of all available visiting permits.

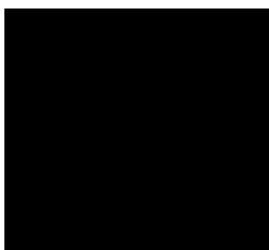
On the 10 October 2000 I spoke to Governor Malcolm Edgar to establish the following:-

- (1) To ascertain if any mobile phones were seized from block H1 (the block where prisoner Hanvey was detained during the period of detention) by prisoner Hanvey.

- (2) Ascertain what if any other phones were available to Hanvey during his detention.
- (3) Ascertain if any record was available concerning letters written and received by Hanvey during detention.

On the 12 October 2000 Governor Edgar reported the following:-

- (1) No record found to date concerning the seizure of mobile phones from H1 block during period of detention.
- (2) Public phones would have been available to Hanvey - the following numbers refer:-



- (3) No record of letters in or out from prisoner Hanvey.

It should be noted that the Maze prison is in the final stages of closure and the administration system is in disarray. Governor [REDACTED] has appointed Prisoner Officer [REDACTED] to archive all remaining documents within the prison. Officer [REDACTED] who has been invaluable to this enquiry has undertaken to inform this office if any further relevant information can be
