



Land Rover at the Alliance & Leicester Building Society. I cannot remember now whether we saw any police officers outside the Land Rover. It was normal to see police somewhere in Portadown, but I could not really say whether I would expect more police at the junction of Thomas, Woodhouse and Market Streets. Although there had been trouble with sectarian clashes at this junction in the past, I did not have any reason to be concerned that night. I had never witnessed any clashes myself but they were always reported in the news.

5. When we got to the Chinese I cannot remember now whether there was anyone at the Chinese that I knew. However, Judith mentioned going around to Tracey McAlpine's house in Brownstown. I did not really know Tracey but I think she was one of Judith's friends. When we got to Tracey's house obviously Tracey was there but I could not say who else was at the house. I was quite drunk and from what I was told I fell asleep. I am not sure if I fell asleep in the living room or in the bedroom. I cannot remember if I even spoke to anyone while I was there. We did not stay long at Tracey's.
6. I have been asked about various people who are connected with this and I can say that at the time I knew Stacey Bridgett. I would usually see him around the Estate and if we were out at night, for example if we went drinking at one of the pubs down the town. Similarly, I was friends with Marc Hobson and also Andrew 'Fonzy' Allen, who lived in the same area as I did. I would meet up with them socially then. I still pass them and speak to them, but I do not bother to socialise with them any more.
7. I know that Stacey was arrested and charged in relation to Robert Hamill's murder but that is not something that we ever discussed. It probably never came up. I was not interested as to how he came to be implicated. I am aware that Marc was actually prosecuted and convicted of affray in relation to the murder. However, again, I did not have any conversation with him about what had happened that

night. I did not visit him while he was in prison nor did I receive any phone calls from him while he was in prison.

8. Even though I knew Allister Hanvey, probably through school, I do not think that I really socialised with him. I also knew Rory Robinson but I would not say that he was a friend. I knew Reserve Constable Atkinson, but just by name. I would have heard his name because he lived in the Portadown area, I think. I do not think that I would be able to recognise him.

I have been asked about **P136** and Philip Lunt as I am told that on 10 May 1997 'Crime stoppers' received an anonymous call naming **P136** Philip Lunt, and myself as being involved in the murder of Robert Hamill. I knew **P136** from drinking in Jamesons. However, I only met him about five years or so ago; I did not know him in April 1997 and I am no longer in contact with him. As for Philip, I do not think that I knew him then and I do not know him now. I have absolutely no idea why someone would call up 'Crime stoppers' and give them my name. The police never contacted me about the 'Crime stoppers' call. This is the first time that I have heard of it.
