friends with her. I knew of Dean Forbes but I do not know from where. I knew of Stacey Bridgett and Marc Hobson because they were Andrew's friends. I did not know Andrew Allen, Tracey Clarke, P46 Lisa Hobson, Wayne Lunt, Phillip Lunt, Rory Robinson, David Woods, P51 or P136
I went to school with Timothy Jameson.

6. On 26th April 1997 I went to the Coach with Andrew as usual. I am not sure what we were doing before we went but we were probably drinking at Andrew's house. The two of us caught the bus from town as usual but I cannot remember exactly from where. It was probably from the same place as we were usually dropped off which I have marked "X" on the map. I cannot remember who else was on the bus.
7. I would only have socialised with Andrew at the Coach. I did see Shelley Liggett but I cannot say who else was there. It has been put to me that I must have known other people who were at the Coach that night because I went there every Saturday night and I would have gone there to socialise. All I can say to that is that I was very drunk and that I knew faces but I was not friends with anyone else.
8. It says in my statement that I got the 01:15 bus back to Portadown. I remember that the bus was full but I cannot remember seeing anyone I recognised on it. I have been asked whether Tracy McAlpine, Pauline Newell, Kelly Lavery, Steven Sinnamon or Dean Forbes were on the bus back but I cannot remember. However, I can remember that Tracey McAlpine told me at some point to come by her house later and this may have been while we were on the bus. She may have told other people on the bus too. I cannot remember what the mood was like on the bus. I guess everyone got off the bus when we were dropped at the usual place but I cannot remember who these people were. My statement says we got off the bus at approximately 01:40.
9. Andrew and I then walked about five minutes to the Chinese takeaway. It was common for people to get food after getting off the bus. Andrew and I did not walk

with anyone else to the take-away and I did not notice who was hanging around Boss Hoggs takeaway. I would say that we left the Chinese takeaway after about 10 minutes at approximately 01:55 to 02:00. From the take-away we walked to Tracey McAlpine's house in Brownstown. We would have walked up High Street on the Thomas Street side and then crossed over onto West Street at St. Mark's church. It would have taken five to ten minutes to walk this route to Tracey's house so we may have arrived at about 02:10.

10. In my statement I referred to a man outside Dorothy Perkins shop but I cannot remember anything about the man now. I also referred to a police Land Rover on the street. I recall that it was parked on the corner by the bank and I have marked its position "L" on the map. I cannot remember which way the Land Rover was facing. I said in my statement that I did not see police on the street but I assumed they were in the Land Rover. I did not look inside the Land Rover. I just assumed the police were in it because that is usually where they were. It was common to see a Land Rover sitting in town.
11. I cannot remember seeing anything out of the ordinary happen as we walked through the town centre that night. I do not remember seeing any crowds or hearing any shouting. I am aware that there was an incident in the town centre between 01:45 and 02:30 but I do not remember hearing any noises or sirens.
12. I said in my statement that I looked up Thomas Street because there was often trouble in the area of this junction. What I meant was that there would usually be the odd fight up there at that time. I am not sure who the fights involved. I had never personally witnessed any trouble at that junction before that night and I do not know anyone who had been involved in any trouble there.
13. I have been asked whether I saw Dean Forbes at the takeaway or whether we walked with him to Tracey McAlpine's house. I cannot remember. I also cannot

remember whether I saw Stacey Bridgett or Marc Hobson that night. I am not sure whether I saw Kelly Lavery at any stage that evening.

14. I said in my statement that Andrew and I only stayed at Tracey McAlpine's house for about half an hour. This is because there were not many other people there. As my statement says, I only saw Pauline Newell and Shelly Liggett there, and Tracy McAlpine was upstairs. I did not see Dean Forbes there and I did not hear anyone talking about an incident in the town centre.
15. I must have heard about the incident afterwards from the news reports. I am not sure exactly when this was. I did not hear any rumours or discussions about the incident afterwards, or any names mentioned in relation to it.
16. I have been told that someone telephoned Crimestoppers and said that Andrew Osborne, Wayne and Philip Lunt, Marc Hobson and **P136** were all involved in the fight that night. I was not aware of this call and I do not know why someone would name Andrew as being involved.
17. I am still in a relationship with Andrew. I know he has remained friends with Stacey Bridgett and Marc Hobson since 1997. He remained friends with them during 1997 and probably had contact with them then. I would meet up with them on rare occasions if I was around. Andrew continues to speak to them now and sometimes sees them in the pub.
