0140ap Moved from front off Alliance & Leicester
Crowd of 50 or more coming up
town stopped by male at
mouth of W'house St theres
a crowd coming down Thomas St
from St Pats. He was faced by a youth
Stacey Bridget. Cornett Spoke to them
They moved off and came over to us.
Bottle of Old English Cider inhand.
Other youth with Bridget stated they
were coming from The Coach had
Give [REDACTED] his card. Pulled at by
Male 30's blue green shirt stocky sh hair
Out of Rover cat calling and shouting
in street at Thomas Street approx
30-50 spread over street. Fight
Broke out. All out of Rover before this
Fight 3 to 1 at Eastwoods. Removed 1
person to Woodhouse St 20's white/cream
Leisure top short neck zip. In W'House
He was punched over my shoulder by
A youth 20 black hair would give name
Taken to Rover. Unable to detain. Then

Police arrived. During this male

I believe I had struck this male with
My baton on the leg at some stage.
Whilst involved in a fraca with R/Con
Atkinson. When holding back the
Crowd I observed Con A up Market
St. with a male (Wayne Lunt) who had a
R/W & B scarf up over face. Assisted her
Brought back to landrover. Saw Stacey
Bridget with blood around his mouth
At the line saw Rory Robinson 20's
short hair black. Thin pointy features
standing with male with goaty beard

leather W'coat. Robinson taunting
person tending injured. Robinson
moved back & forward across line
to get through. Squared up to me on
a couple of occasions drawing his arms
back. (The male with goat beard I had
observed kick.) I also observed a
