NOTEBOOK ENTRY OF D/CONSTABLE EDWARD HONEYFORD FOR 10-5-97

10-5-97

6 45 am Commenced duty. Attended briefing, Portadown, by D/I Irwin re arrests/ searches in respect of serious assaults of D [redacted] and Robert Hamill and the death of Robert Hamill. Briefed re search of [redacted] [redacted] and arrest of Paul Rodney Marc Hobson. Travelled to [redacted] [redacted] accompanied by uniform officers, J1 MSU.

0730 Arrived at 7 30 am. House entered. Mr & Mrs Hobson present. Informed Mrs Hobson of i/d, nature of enquiries, ie search of premises for clothing, in respect of serious assault on 27 April 97. Informed Mrs Hobson of grounds of entry. Copy of warrant

served by Sgt [REDACTED].
Asked Mrs Hobson if her
son Marc Hobson was at
home, Mrs Hobson confirmed
that. Entered premises with
Sgt [REDACTED] and uniform officers.
Went upstairs spoke to
person - Marc Hobson. Searched
wash basket with Mrs Hobson
who removed a grey
coloured sweater from basket
and handed it to me.
This sweater had the name
"MAZUNO" printed on it.
I seized the sweater,
bagged it, marked it
Item EH1. Requested
Marc Hobson to remove the
blue jeans and grey Nike
sweater he was wearing.
Hobson consented. Informed
Hobson reason for seizing
same, bagged and
marked jeans EH3, Nike
sweater, bagged and labelled
EH2. Seized black leather
jacket from rear of
bedroom door "Marc's" room
brand label "Classic", bagged
and labelled jacket EH4.

8 07 am At 8:07 am I reminded i/d

informed Marc Hobson that
I was arresting him for
the murder of Robert Hamill
and serious assault on [REDACTED]
[REDACTED] which occurred at
Market Street, Portadown on
Sunday morning 27 April 1997.

Cautioned Marc Hobson as
follows: You do not have
to say anything, but I
must caution you that if
you do not mention when
questioned, something which you
later rely on in court, it
may harm your defence.
If you do say anything
it may be given in
evidence. Hobson made no
reply. Left [REDACTED]

Returned to Portadown,
