I am a Constable in the Royal Ulster Constabulary presently attached to J2 Mobile Support Unit, Mahon Road, Portadown. On Tuesday 6th May 1997 at 0705 hrs I, along with other Police attended a briefing at Portadown CID Office. As a result of the briefing I was detailed to carry out a search at [REDACTED], the home of Stacey Bridgett, relating to the offence of Grievous Bodily Harm with Intent and Assault Occasioning Actual Bodily Harm on 27 April 1997 in Portadown. The search was for clothing and footwear worn in the said assault. Power of entry was virtue of Article 10 Police and Criminal Evidence (NI) Order 1989. At 0720 hrs I entered [REDACTED], along with other Police. Along with Const Andrews I searched the bedroom belonging to Stacey Bridgett. During the search I seized the following items of clothing and footwear: 1 x 'Watsons' checkered shirt - 'WAS1', 1 x black 'Calvin Klein' shirt - 'WAS2', 1 x blue checkered 'Ralph Lauren' shirt - 'WAS3', 1 x purple/yellow checkered 'Ralph Lauren' shirt - 'WAS4', 1 x grey 'Sonneti' cords - 'WAS5'. All these items were seized from the wardrobe in Bridgett's room. I also seized the following: 1 x cream 'Replay' jeans - 'WAS6' from the sportsbag on the floor, 1 x left footed black shoe/bootee -

'WAS7' from the floor, 1 x right footed black shoe/bootee - 'WAS8' from the floor. I bagged all these items at the scene. The search terminated at 0745 hrs. I sealed, labelled and exhibited the bags as shown at Lurgan RUC Station and at 0830 hrs I passed all the items marked WAS1 - WAS8 to D/Constable Keys, Portadown CID.
