SIGNATURE OF WITNESS

I am a Detective Constable of the Police Service of Northern Ireland currently attached to Regional Crime Squad South Region. On Sunday 21/12/03 at about 10.15 am I received a telephone call to my home from J [redacted]. He informed me that Andrea McKee a crown witness in the case of R -v- Atkinson and others was unable to attend court on Monday 22/12/03 because her son was ill. He further stated that K [redacted] was aware of the situation and that he had directed that I contact Andrea to establish the facts and to ascertain if we could help her situation in any way. At about 10.30 am I spoke to Andrea and she stated that her son [redacted] had mumps and ophthalmitis, which she explained, was swelling of the testicles. She further stated that there was a fear that the child could have a fit due to his high temperature. Andrea explained that the child's illness had started two weeks ago with an ear infection and since then [redacted] has seen the doctor twice at the surgery and once at home and he is to see the doctor again tomorrow morning. She stated that he had been prescribed Amoxicillin and Calpol by [redacted] from [redacted] which is [redacted] in Wrexham. I asked Andrea if there was anything that we could do to help and she said "No not at the moment" she said her child was sick and she was not prepared to leave him with anyone. Andrea was very apologetic but said she could not attend court with her child so sick. I enquired if she could attend on Tuesday 23<sup>rd</sup> and she said "definitely not". I also asked if she thought she might be able to attend the following Monday and Tuesday. She didn't know about this but felt that she would have to say no as she didn't know how much better

██████ would be and she would not leave him if he was ill. When asked about future available dates she explained that she was going back to college at the beginning of January and ideally she would like to attend court before her workload became too great or at half term which was 13<sup>th</sup> - 23<sup>rd</sup> February. Andrea again stressed how sorry she was for "mucking things up" and I told her I would be in touch with her about future arrangements. The conversation then ended.
