On Saturday 26th April 1997 I got the 9 pm bus from Portadown over to the Coach Disco in Banbridge. On Sunday 27th April 1997 then I missed the bus back to Portadown and got a taxi back to Portadown with [REDACTED] and [REDACTED]. The taxi dropped us off at the VG Stores in Killycomain. I left them and started to walk towards the town centre. Around about Edenderry Methodist Church Christine Bigg who was driving her Escort car stopped to give me a lift. In the car was Chris Henderson and P43 [REDACTED] Christine dropped Chris and I off at Herrons at the bottom of the town. This must have been around 2 am. The second bus had come into Portadown dropped people off and left again and we were still talking. It must have then been well after half two. We started walking up the town and saw an ambulance pulling away from the end of Thomas Street. I recall seeing a few police landrovers in the town and a crowd heading out of the town toward Brownstown. Chris and I walked on up to the Cam Hing Chinese in West Street and met a few more friends. We walked over the footbridge into Edgarstown and Stephen Bloomer, Marc Hobson and I think Alister Hanvey went to Tracy McAlpine's house. I don't know where Chris went. I eventually walked down to [REDACTED] to [REDACTED]

house and joined the others there. This must have been after 3 am.  
At the house I recall seeing Pauline, [REDACTED] sister, Shelly Liggett,  
Kelly Lavery, Alister Hanvey, Dean Forbes, Jason Woods, Marc Hobson,  
Stephen Bloomer, P46 [REDACTED], Chris Henderson and Andrew Allen.  
Most were sleeping. I didn't hear any talk about a row in the centre  
of the town. It was just general chat. I left at about half five a  
quarter to six. Stephen Bloomer and I got a taxi home from Call A  
Cab. We walked to the office from [REDACTED].
