On Saturday 26 April 1997 myself, Tracey McAlpine and Pauline Newell went over on the 9 pm bus to the Coach in Banbridge. We saw Vicky Clayton and a girl I know as Jennifer on the bus. We caught the first bus from the Coach back to Portadown at about 1 15 am on Sunday 27th April 1997. We got into Portadown sometime around a quarter to two in the morning. I remember seeing Vicky Clayton, Shelly Liggett, Jennifer and Tracey Clarke on the bus coming back and two fellows I know Dean Forbes and another boy I know as Stacey. I can't remember what they were wearing. I fell asleep on the bus and was wakened by Tracey McAlpine when we got back to town. Tracey, Pauline and I walked up the town. Pauline went into Boss Hoggs to get something to eat and Tracey and I walked on. We crossed over the street and I do recall seeing a police landrover in the centre of the town in one of the streets. I didn't know which street but now think it was Woodhouse Street. There was no row or commotion in the town when Tracey and I walked through it. Somewhere just past the Church Pauline caught up with us. I wasn't aware of anything going on then either. We walked on to Tracey's house I don't know Tracey's address but its one of the new houses in [REDACTED] When we arrived there I

went upstairs to bed and fell asleep there were only the three of us in the house when I went upstairs. Pauline went up to bed as well. Before I went to sleep I heard voices but don't know who was downstairs at all. Early in the morning I woke up and spoke to Tracey. I asked if she would go to the shop with me. She agreed to go and we walked to the all night Esso station (on the Armagh Road). I got an ice lolly and a packet of crisps then walked back to Tracey's. Just the two of us walked no one else. When we got back I went into the living room and sat down where I fell asleep. During the time I was asleep someone painted my face with makeup. When I woke up and saw what they'd done I threw anybody who didn't belong there out. I don't know who all was in the house but I did see Dean Forbes there and another fellow who I know only to see through Tracey. He's called Allister Hanvey. After I'd thrown them all out I got my stuff together and went home. I walked up through the town with Tracey Clarke and saw that it was blocked off by police. We asked what had happened and were told that there'd been a few boys rowing in the town. This was the first I'd heard about anything in the town. I didn't here any talk of it at Tracey McAlpine's. Tracey Clarke and I walked down to Eden Cabs and got a taxi home. I got in about 9 am on Sunday morning.
