On Saturday night past 26th April, 1997 I went to the Coach disco, Banbridge. I went on the bus from Portadown along with several mates, Johnny Nelson, Connor Black, Stephen Bloomer and Christopher Henderson. I got the bus back from Banbridge to Portadown. The bus left the Coach about 1.15 am and arrived in Portadown at approximately 1.50 am. I travelled home on the bus with the same mates as I went with. I can't remember seeing Christopher Henderson on the bus coming home. I got off the bus at the bottom of the town at "Herron's" Country Fried Chicken. There was a crowd of us got off the bus. Connor Black and Johnny Nelson went into "Herron's", I walked up to "Boss Hoggs" with Stephen Bloomer. There were others walking up the street. I went into "Boss Hoggs", I didn't purchase anything. I just went into it because the crowd went into "Boss Hoggs", I can't remember if Stephen Bloomer went into "Boss Hoggs". I came out of "Boss Hoggs" and stood outside the premises. There was a large crowd standing outside "Boss Hoggs", I stood there for about ten to fifteen minutes. Victoria Clayton and Jennifer O'Neill were also outside "Boss Hoggs", and I spoke to them. I then ran back down to "Herron's", to see Connor Black. I asked Connor if I could go back to

his house as I knew his mother and father were away. I asked Connor if I could bring Victoria Clayton and Jennifer O'Neill back. Connor said, "No," as his sister was at home. I walked back up to "Boss Hoggs" and met up with Victoria and Jennifer again. I stood outside "Boss Hoggs" with the two girls. I think Timothy Jameson and Stephen Bloomer were standing beside us. The next thing I saw was a crowd starting to fight on the middle of the street, at the junction of Woodhouse Street with Thomas Street. There would have been about twenty fighting. I started to walk towards the fight and Victoria and Jennifer walked with me. I am not sure if Timothy and Stephen came up the street. I got near the fight, I got close to it. I saw about twenty boys fighting. The police landrover was parked outside the Alliance & Leicester Building Society and I saw a couple of police officers get out of the landrover and walk towards the fight. I started shouting at the police, I can't remember what all I called them. I then walked up towards the Church with the two girls Victoria and Jennifer. The crowd was still fighting. I walked up to the Church, Jason Woods was standing about there. I walked down to the summer seats, just down from the Church towards the town centre. I sat down with Victoria and Jennifer for a few minutes and watched the fight. The ambulance arrived. I observed a fellow lying on the ground in the middle of the road on Thomas Street side of the main street. I think he was lying in a pool of blood. The police had got the fight under control by now. The police marched the people up the town up past the Church. I walked up West Street with Victoria and Jennifer to. I then walked back on my own. I met Johnny Nelson and

Connor Black outside "Call-a-Cab". I got into a taxi and went to Connor's for ten to fifteen minutes and then walked home. I was drunk on Saturday night when I shouted at the police. I also shouted something about "fenians", when I was walking past the fight.
