Today the 24th of April 2001 I have been asked if I visited Michael and Andrea McKees at [REDACTED] on the 27th of April 1997 along with my wife [REDACTED]. I can state that we couldn't have been there on that date because I didn't meet [REDACTED] until the 4th of July 1997. At that particular time I was going through a divorce and I wasn't with any woman. I am sure I met [REDACTED] on the 4th of July because that was my wedding anniversary for my first marriage. I met her at a nightclub in Irvine, Scotland called Amandas. It now called Club 30. [REDACTED] is from Irvine and was at a private birthday party for one of her friends. I gate crashed the party with several others. We were attending a Tai Kwon Do competition which was being held in Paisley and were staying at the Holiday Inn Irvine. It is now called the Thistle Hotel. We were booked in under the Ulster Tai Kwon Do Club. There was around fifteen team members and some of the teams family which would have been a total of twenty staying at the Hotel. I also met [REDACTED] on the Saturday and she came to the competition in her own car on the Sunday. I introduced [REDACTED] to Michael and Andrea McKee at the competition. I was living at [REDACTED] Portadown. [REDACTED] visited me around the period of the twelve of July.

This was the first time [REDACTED] visited the McKee's at [REDACTED] Andrea had a barbeque for [REDACTED] because it was the first time she had ever visited Northern Ireland. At no time did Michael or Andrea McKee discuss the murder of Robert Hamill. I have been asked if I know Alistair Hanvey Robert and Eleanor Atkinson. I know them from the Tai Kwon Do Robby Atkinsons daughter [REDACTED] is a member. At no time did they discuss the murder of Robert Hamill with me. [REDACTED] and I were married on the 22nd of December 1998. [REDACTED] lived with me on a permanent basis from around August 1997. Michael and Andrea McKee were witnesses at our wedding. We were quite friendly with them at the time and visited their house quite often. Our friendship ended when Michael done a runner from the Club about two years ago March 1999 and left me with all the responsibilities.
