COLIN HULL [REDACTED] WAS SPOKEN TO BY MYSELF ON EVENING OF 090597. PROFORME COMPLETED AND ATTACHED. LEFT ST PATRICKS HALL AT 0130HRS APPROX ALONE STOOD ABOUT FOR 5 MINUTES WAITING FOR A TAXI, HE WALKED OFF WHEN ONE DIDNT TURN UP HE WALKED OFF ALONG THOMAS ST ALONE. STATED THAT ROBERT HAMILL, [REDACTED] AND 2 WOMEN WERE WALKING ABOUT 15 YDS BEHIND HIM. AT SOME STAGE HE WALKED PAST COLIN PRUNTY WHO SAYS WAS ALONE. HE WALKED ACROSS THE MAIN STREET TOWARDS WOODHOUSE ST AS HE WAS DOING SO HE SAW ABOUT 20 PEOPLE SPACED OUT IN SMALL GROUPS THE FIRST OF WHICH WAS NEAR RONNIES. HE WAS CALLED A FENIAN BASTARD HE WALKED ON TO 1/2 WAY DOWN WOODHOUSE ST, WHEN HE HEARD FENIAN BASTARDS BEING SHOUTED HE TURNED ROUND AND WENT BACK UP TO THE TOP OF THE STREET. AT THE TRAFFIC LIGHTS HE SAW PEOPLE JUMPING ON ROBERT HAMILLS HEAD, HE SAID TO POLICE WHO WERE NEAR ARE YOU NOT GOING TO STOP IT OR DO ANYTHING ABOUT IT. HE WENT OVER TO TRY AND STOP THE FIGHTING, WAS KICKED AND PUNCHED AND THE CROWD WERE SHOUTING 'DIE YOU FENIAN BASTARD YOU' 'THIS TOWN IS OURS' HE WILL MAKE WITNESS STATEMENT ON SAT 100597.
