LISA HOBSON, [REDACTED] SPOKEN TO IN PRESENCE OF HER MOTHER, [REDACTED],
[REDACTED] LISA IS CURRENTLY STAYING WITH [REDACTED], [REDACTED]
TN [REDACTED] SHE STATES THAT SHE WAS AT MICHELLE JAMIESON'S HOUSE ON THE
NIGHT OF SAT 26 4 97 AND THAT MICHELLE JAMIESON, JOANNE BRADLEY,
HEIDI REANEY AND WAYNE LUNT WERE THERE. THEY WERE DRINKING AND LISTENING TO
MUSIC. HOBSON CLAIMS THAT AT ABOUT 0035 HRS ON SUNDAY 27 4 97 ALL 5 LEFT THE
HOUSE AND WALKED JOANNE BRADLEY TO THE FOOTBRIDGE TO UNION
ST WHERE THEY LEFT HER BEFORE GOING INTO PORTADOWN TOWN CENTRE WHERE THEY
INTENDED TO MEET THE COACH BUS. SHE STATES THAT ON HER WAY TO MEET THE BUS
ALL FOUR WERE STILL TOGETHER WHEN A ROW DEVELOPED ON THE OTHER SIDE OF THE
STREET AND THAT AT THAT TIME THEY WERE OUTSIDE THORNTONS SHOP. SHE IS VERY
VAGUE ABOUT WHAT HAPPENED AT THAT TIME BUT STATES THAT THEY GOT SEPARATED.
SHE DID RECALL SEEING LUNT BEING PUT IN THE POLICE LANDROVER AND CLAIMED HE
HAD NOT BEEN INVOLVED IN THE FIGHT BUT COULD NOT SAY HE WAS IN HER VIEW
BETWEEN THE START OF THE FIGHT AND LUNT BEING PLACED IN
THE LANDROVER. SHE ALSO RECALLS MEET UP AGAIN WITH MICHELLE WHO AT THE TIME
WAS STANDING OVER ONE OF THE IP'S. SHE DENIES BEING AT THE PARTY IN
MCALPINES AND CLAIMS TO HAVE WANDERED ABOUT AND EVENTUALLY FELL IN WITH
NOELLE MOORE [REDACTED] AND THEN [REDACTED] [REDACTED] KENNY MILLIGAN OF
[REDACTED] AND LEE STOCKDALE, [REDACTED] SHE STATES THAT THEY WERE IN
JERVIS ST WHEN MOVED ON BY POLICE AT ABOUT 6 AM. REFUSED TO MAKE STATEMENT.
LISA FURTHER STATES HER FATHER WAS THE SUBJECT OF A BEATING, [REDACTED].
