NO RECORDS LEFT REGARDING HIS DEALINGS WITH SKANX HE STATES HE BELIEVES
THAT HE SOLD ALISTAIR HANVEYS GIRLFRIEND A DANIEL POOLE COAT BUT NOT SKANX
HE WOULD NOT ALLOW ME TO RECORD IN HIS STATEMENT THE FACT THAT THERE WAS A
POSSIBILITY THAT HIS SHOP SOLD ANY SILVER JACKETS WITH ORANGE STRIPES DOWN
THE SLEEVES HE WOULD ONLY SAY HE HAS NO RECOLLECTION OF SELLING SUCH
JACKETS FROM HIS SHOP HE STATED IF HE WAS ASKED IN 10 COURTS HE WOULD SAY
THAT IT IS POSSIBLE BUT WAS ADAMANT THAT THIS WOULD NOT BE INCLUDED IN HIS
STATEMENT ON SEEING THE EXHIBITS AM5 AND AM6 HE STATED THAT HE MAY HAVE
BOUGHT SIMILAR CLOTHING FROM SKANX BUT DID NOT RECALL BUYING THESE ARTICLES
AS DISPLAYED ON AM5 & AM6 I FOUND HIM DOGMATIC WHEN I WAS RECORDING THIS
STATEMENT AND AS CAN BE SEEN FROM THE STATEMENT CONTENT HE WANTED HIS
