INTERVIEWED V CLAYTON AT HER HOME IN PRESENCE OF HER FATHER  
SHE RELATED THAT ON THE NIGHT OF 26-27 4 97 SHE WAS AT THE  
COACH INN BANBRIDGE AND THAT SHE TRAVELLED HOME ON A BUS WITH  
JENNIFER O'NEILL TO PORTADOWN THERE SHE WALKED UP TOWN CENTRE  
GETTING CHIPS ON THE WAY STATES SHE MADE HER WAY TO THE AREA  
OF THE CHURCH AT 'THE TOP OF THE TOWN' WHERE SHE ATE HER CHIPS  
V CLAYTON WOULD SAY THAT ON THE WAY PAST THE THOMAS STREET  
JUNCTION SHE WAS AWARE OF PEOPLE ON THE MAIN STREET GENERALLY  
BUT THAT THERE WERE NO DISTURBANCES TAKING PLACE AT THIS TIME  
AND SHE DOES NOT RECALL HAVING SEEN ANY POLICE TAKING ANY FORM  
OF ACTION IN RELATION TO MEMBERS OF THE PUBLIC ON THE STREET AS  
SHE MADE HER WAY TO THE AREA OF THE CHURCH V CLAYTON STATED  
THAT WHILST SHE WAS IN THE AREA OF THE CHURCH THE DISTURBANCE  
TOOK PLACE AT THE JUNCTION OF THOMAS STREET BUT THAT SHE DID

KNEW TRACY CLARKE OR ALLISTER HANVEY SHE SAID THAT KNEW THEM TO  
SEE BUT HAD NO ASSOCIATION WITH THEM WHEN ASKED IF SHE KNEW  
ROBERT ATKINSON HER REPLY WAS UNCONVINCING AND SHE HESITATED  
STATING THAT SHE HAD HEARD THE NAME BUT DID NOT KNOW HIM EVEN  
TO SEE SHE ALSO STATED THAT SHE CANNOT RECALL HAVING SEEN  
TRACY CLARKE OR ALLISTER HANVEY IN PORTADOWN AT THE RELEVANT
